

- The firm intending to participate in the tender shall be a manufacturer of the product or their authorized dealer/ supplier and should submit the certificate of authorization in force.
- The successful bidder is to supply and deliver the vehicle as per the specifications mentioned in Annexure- I. The vehicle shall be delivered at office of the undersigned.
- The bidder should submit copy of the Dealer Registration Copy, Authorisation copy, GST Certificate from the competent authority along with the technical bid of the tender paper submitted.
- The bidder should submit the tender in two separate envelop covering Technical Bid and Commercial Bid separately giving full details with supporting documents as required.
- Both the bid document will be placed in a separate envelop mentioning the tender reference and date of opening of the tender.
- The Technical bid envelop should contain the technical details about the bidder.

- **Delivery:**

The goods are to be delivered in good condition as per the delivery schedule within 30 days from issue of the purchase order. If the vehicle is not delivered within time, a penalty at the rate of 0.5% of the purchase cost of the vehicle will be charged per week or its fraction thereof. The supplier shall make his own arrangements for supply and delivery of vehicle at the office of the undersigned any damage during transit prior to delivery will be responsibility of the supplier.

- **EMD :**

The bidder is required to deposit an earnest money (EMD) of Rs. 10,000/- (Rupees ten thousand only) in form of a Bank Draft drawn from a Nationalized bank in favour of " Deputy Director (P&S), DPMU, Kendrapara" payable at Kendrapara. The earnest money shall be refunded without any interest to the successful bidder after supply of the vehicle and to the unsuccessful bidder on finalization of the tender without any interest.

- **Price :**

The price quoted by the firm should be in Indian Rupees for delivered at the destination.
