**Pre Qualification criteria of the CA-Firm:**

- Be a partnership firm with 5 or more partners and have minimum 10yrs of existing after its registration.
- Registered with the institute of Chartered Accountants of India (ICAI) and have Income Tax Permanent Account Number (PAN) and GST Registration.
- Based at Odisha and empanelled as per latest order of Comptroller and Auditor General of India(C&AG).Preference will be given to the firm having office at kendrapara District.
- Have experience in Govt. Sector Audit and supporting should be attached.
- Last three years average annual turnover should not be less than 10.00lakhs.
- Not have been blacklisted by any govt. or any other organization. Authorized Signatory(s) of the firm to submit an undertaking to this effect.

Submit relevant documents duly attested by the authorized signatory in support of the eligibility criteria given above.


