Quotation Call Notice

Sealed quotations/ tenders .invited from interested reputed Travel Agencies / Tour Operators or private individuals for one **Indica eV2** which shall confirm to the Terms and Conditions (Annexure-II) for official use in Revenue Section, Collectorate, Kendrapara on monthly rent basis.

- 1) The vehicle must be road worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for playing of vehicle.
- 2) The Driver of vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 3) The driver should be well behaved, gentle and obedient in nature.
- 4) A sum of Rs.5,000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the Collector, Kendrapara and submitted along with the tender as security deposit. After completion of the tender process, the amount will be refunded to unsuccessful bidders.
- 5) The monthly rate of hire charge be quoted separately in general bid information (excluding fuel & lubricant) within the hire charges of Rs.16,000/- per month.
- 6) The vehicle must achieve a fuel efficiency of 17 Kms per liter.
- 7) The details of make and year of manufacture of the vehicle registration No., mileage and name of the Driver with D.L No. and period of validity should be specifically provided in the general bid information to be furnished with the quotations/ tenders (Annexure-III)
- 8) The Quotations completed in all respect should reach the undersigned on or before **31.07.2019 by 2.00PM** and shall be opened on the same day at **3.00PM** in presence of the bidders or their authorized representatives.
