- 7,000 Youth Clubs will be supported @ Rs. 15,000/- per Youth Club
- The District wise Target of Youth Clubs to be assisted are enclosed.

Eligibility Criteria:


Registered under society registration Act 1860 or any other corresponding State Act or affiliated with NYK or has been in existence for last two years providing satisfactory documentary evidence of work done.

Selection process:

- The financial assistance so sanctioned in favour of Youth Clubs shall be released preferably through their respective Bank Account under RTGS/NEFT/Account Payees Cheques.
- A screening committee would be constituted for selection of the Youth Clubs for availing the Grants as under:

01.	Collector	Chairman
02.	PD, DRDA	Member
03.	Executive Officer of ULB/BDO of concerned Block	Member
04.	Youth Coordinator, NYKS	Member
05.	District Sports Officer	Member-Convener

- The selection would be made through a marking procedure on a 50 point (Annexure-I). In case of more than one Youth Club of a particular area securing equal marks, the oldest registered Youth Clubs will be eligible for the grant.


