OFFICE ORDER

In order to strengthen the security of ERONET System, Election Commission of India has directed to implement the restriction to access to ERONET from whitelisted IP address only by 15th September, 2021. The whitelisting of IP address requires fixed IP address(es) from where the system is being accessed this requires either internet leased line or Broadband /FTTH connection with fixed IP address. In this connection Govt. in Home(Elections) Deptt. Odisha, Bhubaneswar has issued an addendum (copy enclosed) as against previous proposal issued vide RFP No- 4904/Elec Dt. 21.8.2021 and revised the schedule of the tender for selection of Computer Firms. The revised date for opening of General Bid is fixed to 23.9.2021 at 3.00 PM instead of 14.9.2021 and Financial Bid on 27.9.2021 at 3.00 PM. instead of 16.9.2021.



As per Annexure-I-A of the RFP No.4904/Elec. dt.21.08.2021 the bidder will have to give an UNDERTAKING /CERTIFICATE that the bidder will ensure establishment of operation centre(s) at the Sub-Division dedicated manpower before signing of the agreement to execute the RFP related works. Headquarters with the availability of prescribed infrastructures and
3. In addition to the ten items prescribed, the bidder will ensure whitelisted IPs to access ERONET as per the guideline of ECI communicated vide Letter No.485/Comp/ERONet/Security/2021/IT-III dt.03.09.2021(copy enclosed).
4. The bidders who have already submitted their bids will be allowed one more week time to submit revised bids to facilitate there to accommodate the cost of fixed IP Plan.
5. Taking into consideration of the above the schedule of the tender is revised hereby as follows:

Sub: Restriction of access to ERONet system from whitelisted IP addresses. Reg.

Sir/Madam,

In order to strengthen the security of ERONET system, it has been directed to implement the restriction of access to ERONet system from whitelisted IP addresses only by 15 September 2021. The whitelisting of IP addresses require fixed IP address(es) from where the system is being accessed. This requires either internet leased line or Broadband/FTTH connection with Fixed IP address. The ERONET system are being primarily accessed from office of CEOs, DEOS, EROS & AEROs and all offices may not have fixed IP connectivity at present. It is observed ISP's tariff plan that approx. Rs 2000 per annum may be the additional cost for one fixed IP address per Broadband /FTTH connection.

CEO's are requested to collect the detail of fixed IP addresses from all AEROS/ EROS/ DEOs through DEOs and inform to ECI/CDAC to whitelist same for access of ERONET before 15th September 2021. In case of non-availability of Fixed IP connection with any office, CEOs may instruct the concerned officer to convert their connection with fixed IP plan within by 14th September 2021 and inform same to ECI /CDAC so that there will not be any issue in accessing the ERONET otherwise it would not be accessible.
