In pursuance of Odisha District Revenue Services (Method of Recruitment and Conditions of Services) Rules- 1983 and subsequent amendment Rules made thereof, the following **29 (Twenty Nine)** candidates, who have come out successfully in Combined Recruitment Examination (CRE)-2021, pursuant to advertisement No- III-E-121/2021-999(C)/OSSSC dt. 30.09.2021 conducted by Odisha Sub-Ordinate Staff Selection Commission, Bhubaneswar and subsequent instruction made thereof vide Letter No. IIE-63/2022/2064/OSSSC dtd. 07.12.2022 of Joint Secretary Sub-ordinate Staff Selection Commission, are hereby appointed temporarily to the post of **AMIN in Kendrapara District on regular basis** in Level-03 (prescribes in the scale of pay Rs.18000-56,900) in Cell-1 of first schedule of the Pay Matrix under Odisha Revised Scale of Pay Rules- 2017.


They are required to report before the authority concerned as noted against them and produce the following documents/ certificates in original for verification.




