**NOTIFICATION**

Sub: Extension of date for applying PIA to provide/manage services for promotion of Transgender equality & justice under SWEKRUTI Scheme.

This is to notify that the SS&EPD Department has decided to extend the Scheme "Programme & Activities for Transgender (SWEKRUTI) to a large number of beneficiaries, since they are one of the most vulnerable sections of the society, non-discrimination, recognition and special provisions of welfare measures are highly required. A PIA /NGOs formed by transgender persons or those working for Transgender persons will be selected through issue of EOI in the prescribed model for implementing the scheme. As such, the proposal in prescribed format are invited within a 7 working days up to 31<sup>st</sup> January 2023.from such institutions, PIA/NGO formed by the transgender persons or those working for Transgender persons. The details of eligibility criteria are as hereunder.

1. The agency should be formed and operated by Transgender persons and working for transgender persons.
2. The agency should be registered Society/ Trust/Company and must have registered with appropriate registration authority.
3. Must have a PAN and 12AB registration under Income tax Act and or GST and should furnish the copy of return filed below competent authority ;
4. The agency should be working in similar and allied fields with proficiency and understanding of different programs. The agency should also have expertise and manpower in providing services;
5. The bidder is required to furnish the audited balance sheet, income and Expenditure Account statement of the last three financial year duly signed by a Chartered accountant ;
6. Should not have any track record of contract termination of the previous assignments or any adverse report of performance or blacklisted by any state Govt. / Central Govt. Organization.

The interested agencies should submit application form along with all relevant documents before the DSSO within the above dateline after which the eligible implementing Agency Shall be selected through holding of Evaluation Committee of DSSO Section as per instruction of the department.
