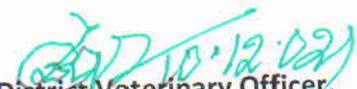

Terms and conditions

1. The quotation must accompany a bid security cum performance security of Rs 500/- payable in shape of demand draft/ Banker's cheque of any Commercial bank drawn in favour of Chief District Veterinary Officer, Kendrapada. Quotationers must mention their account no. and IFSC to return the security value to the unsuccessful bidders.
2. The sealed envelope containing quotation should be super-scribed as "Quotation for hiring vehicle on daily basis in reference to Advt. no..... dt....."
3. The quotationers shall furnish the following documents along with the quotation in support of their eligibility
 - a. Undertaking to provide good conditioned vehicle not more than 3 years old
 - b. Undertaking that the firm/ agency/ supplier has not been debarred/ blacklisted by any Govt. organization/ Semi-govt. organization/any PSU.
 - c. Undertaking that the vehicles to be provided will not belong any employee of the establishment of CDVO, Kendrapada.
 - d. Rates must be quoted as format.
4. GST will not be taken into consideration for evaluation purpose.
5. A comparative statement shall be prepared on the basis of per hr. price quoted (local tour) and on basis of per km (long tour). The lowest bidder has to agree to the other charges like lowest halting charge, night halt charges, extra km. rate etc. offered by other bidders.
6. The daily rate for providing the vehicle is inclusive of the cost of fuel, lubricants, tyres & tubes, consumables, all major and minor maintenance works with spares and all payment towards Driver's salary, his fooding cost, overtime and mobile phone charges of the driver.
7. The cost of kilometers from o/o the agency to the o/o CDVO, Kendrapada (to & fro) shall be borne by the agency.
8. The hired vehicles, during the period of contract, shall have all necessary valid MV documents such as valid Registration Certificates, Insurance Certificates, Fitness Certificates, valid Contract Carriage Permits, proofs of up to date tax payments, D.L.s of the Drivers etc. available all the times. The CDVO/ User shall not be responsible for any damage/loss caused to the hired vehicles or loss of life / injury made to any person or damage to any property on account of use of hired vehicles in any manner whatsoever. The service provider shall be responsible for all such litigations.
9. The driver in no case shall report to duty in an inebriated state or consume alcohol while on duty. In such an event, user department shall have full rights to terminate the contract, with immediate effect.
10. Driver must be having a mobile phone and contact number be provided to CDVO. The agency shall bear all cost related to the mobile call charges by the drivers.
11. The Agency shall be personally responsible for any theft, misconduct and/or disobedience on the part of drivers so provided by him.
12. The vehicles deployed for duty shall at no point of time carry any person other than personnel authorized by user department
13. In case, the condition of vehicle is found unsatisfactory, it shall be returned for immediate replacement. Repeated failure to provide vehicles as and when required by the CDVO will make the agency liable for Blacklisting.
14. The accepted price will be valid up to one year.
15. The undersigned reserves the right to terminate the quotation at any time in case of unsatisfactory performance.
16. Quotations received if incomplete or after the scheduled date and time will not be entertained.
