2. Pisciculture through Bio floc technology by SHGs.
3. Fish and Fish seed production in Govt. Fish farms by SHGs.
4. Excavation and input support for new brackish water shrimp ponds in Government land by SHGs.

1. Broiler farming (1000 Bird Capacity) under Deep Litter System.
2. Back yard Poultry cluster for individual SHG members.
3. Goat Rearing (30+2 unit size)

1. SHGs for these proposed interventions include SHG Federations.
2. SHG must have completed 2 years
3. from the date of formation.
4. SHG should belong to the same GP where they propose to take up the activity.
5. SHG must have an active bank account.
6. SHG must not be a bank loan defaulter.
7. SHG must have undertaken regular and systematic book keeping including maintenance of meeting register, cashbook, updated passbook among others.
8. SHG undergone training at Krishi Vigyan Kendras (KVKs) or by FARD Department on corresponding livelihood activities (Fisheries and Animal Husbandry) will be given preference from among the applicant SHGs/SHG Federations.
