TERMS AND CONDITIONS OF QUOTATION FOR "Engine Control Unit"

- 1) Intending supplier/firm having supplied similar item of similar magnitude earlier and satisfactorily accepted by the clients will be eligible to participate in the quotation.
- 2) The quotations will be received at the office of the Collector Kendrapara (Emergency Section, At-Garapur, (Near Residential Office of the Collector, Kendrapara)) by **16.09.2022 at 3.00PM**. If there will be a public holiday on the last date of collection of quotation document and receipt & opening of the quotations as specified above, the quotation document can be collected on the next working day at the same time and venue and quotations will be opened on the next working day at the same time and venue.
- 3) The quotation will be opened on **16.09.2022 at 04.00 PM**. in presence of the quotationers or their authorized representatives, if they so desire.
- 4) The materials will be guaranteed by the supplier against any defect for a period of 12 months from the date of supply or 6 months from the date of use, whichever is later. Guarantee certificate in this regard will be accompanied with supply of materials. If any defect is found in the materials within the guarantee period, the same will have to be replaced free of cost by the supplier.
- 5) The rate of materials should be quoted by the quotationer on unit basis only.
- 6) The successful quotationer shall have to furnish a performance bank guarantee for 3% of value of materials within 07 days from the date of issue of Purchase Order. The Bank Guarantee shall be released after completion of the guarantee period and clearance from proper authority.
- 7) The quotationer will quote their rates for , Office of the Collector Kendrapara (Emergency Section, At-Garapur, (Near Residential Office of the Collector, Kendrapara)) indicating separately the basic price, taxes, etc. strictly in the price schedule format in original. All columns and lines of the price schedule should be filled in properly without leaving anything blank.
- 8) The quotationer should quote appropriate taxes with the offer.
- 9) The rates and amounts should be quoted both in figures and words in the price schedule. Any correction or overwriting in the specification and price schedule should be duly certified by the quotationer or his power of attorney holder. In case of any mismatch in figures and words, the rates in words will be considered. In case of any mismatch in rates and amount, the rate will be considered.
- 10) 100% payment will be made within 30 days of receipt, verification and acceptance of the complete materials along with bill, guarantee certificate and other documents.
- 11) Price escalation will not be allowed under any circumstances. The quoted rates will remain firm till execution of the work order.

- 12) The validity of the offer should be for a period of 90 (Ninety) days from the date of opening of the quotation.
- 13) The complete ordered quantity shall be supplied by the successful quotationer within 10 (ten) days from the date of issue of purchase order failing which the order is liable for cancellation without assigning any reason thereof by the purchaser.
