

1. The rate quoted should be inclusive of all taxes, transportation and installation charges. No extra charges will be met on or above quoted rate.
2. Technical specification of the Battery is Valve Regulated Lead Acid Battery (12v, 100AH/ 20HR).
3. The quotation should be valid for minimum two month from the date of submission of quotation.
4. The supplier should have valid authorized dealer certificate of that product/ item.
5. The warranty card should be supplied duly signed by the supplier.
6. Replacement warranty of the Battery should be Minimum 2 years. No extra charges will be given in that period towards transport, installing, commissioning etc.
7. The replacement of item in warranty period should be done within 15 days of the receipt of the complaint.
8. 2% of the total cost should be deposited as **EMD (refundable)** in shape of DD in favour of District Project Coordinator, SS, Kendrapara payable at Kendrapara with the bid document.
9. 5% of the total cost should be deposited as **Security Deposit (refundable)** in shape of DD in favour of District Project Coordinator, SS, Kendrapara payable at Kendrapara before the execution of the work.
