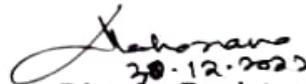

TERMS AND CONDITIONS OF APPOINTMENT:-

- (i) The re-employment in respect of retired Group - 'D' employees shall be made initially for a period of two years, which may be further extended for subsequent period of two years with spells of one year each subject to satisfactory performance up to a total period of four years not beyond the age of 65 years of age in any case or till the posts are filled up by regular process whichever is earlier.
- (ii) Re-employed employees will be entitled to pay and other allowances as determined by the Administrative Department / Appointing Authority with the concurrence of the Finance Department.
- (iii) Re-employed employees shall be governed by the provisions of Odisha Government Servants Conduct Rules, 1957 and shall be liable to be proceeded against for their misconduct, omissions and commissions as per the provisions under the Odisha Pension Rules, 1992.
- (iv) The re-employment can be terminated at any time by the Competent Authority due to unsatisfactory performance of any of the re-employed employee by giving one month notice. On the contrary if any re-employed employee desires to resign he shall do so by giving one month's written notice to the competent authority.

ELIGIBILITY:-

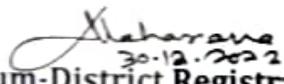
- (i) The appointment of Group-D staffs who have retired from Government services on attaining the age of superannuation and below the age of sixty five years having good service records and are physically fit shall be eligible to be considered for re-employment.
- (ii) The retired Group-D employees against whom departmental proceedings or criminal cases are contemplated / pending or who have been penalized for misconduct during the period of proceeding five years will not be eligible for consideration.

PAY AND OTHER ALLOWANCES:-

1. The monthly remuneration will be fixed as per Finance Department O.M. No. 7022/F dated 17.03.2018 or as revised time to time by the Government of Odisha.

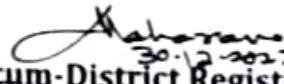
GENERAL
