5. The undersigned reserves the right to cancel any or all bidders without assigning any reason thereof.
6. The bidder will deposit as refundable Bid security @ 2 % of maximum cost of items (Rs.9900/-) in shape of A/C payee Banker's cheque, DD, from any commercial bank, drawn in favour of Chief District Veterinary Officer, Kendrapada along with tender papers.
7. The Bid security value will be returned to all unsuccessful bidders on tender opening day and to successful bidder after deposition of performance security.
8. The bidder should collect the Bid security money from CDVO Office, Kendrapara in the event of disqualified bidding.
9. The bidder should attach the GSTIN clearance certificate, Photocopy of PAN and ID proof (AADHAR/ Voters' IC/ Driving Licence/ Passport/any other document issued by Govt. Of Odisha or Govt. Of India) along with the tender papers.
