For Engagement of Mobile Veterinary Unit of Nine Blocks-Marshaghai, Rajkanika, Mahakalpada, Derabis, Garadpur, Kendrapara, Rajnagar, Aul&Pottamundai.

Quotations/tenders in sealed envelope super-scribed with "Tender/Quotation for engagement of Vehicle in Mobile Veterinary Unit, Block. _____ Dist.Kendrapara." are invited from interested reputed Travel Agencies/Tour Operators or private individuals having, GST registration for providing nine nos. of Non AC Diesel/Petrol vehicles for nine blocks of Kendrapara district having sitting capacity not more than ten including driver, which shall conform to the General Terms and conditions (Annexure-I) for Mobile Veterinary Unit under Chief District Veterinary Officer, Kendrapara- on monthly rent basis:

- (1) In view of the pollution being high through use of Diesel vehicles, it is preferable to hire BS-IV Compliant petrol vehicles.
- (2) Types of vehicle permissible to be hired is TVU-300/Bolero/Sumo Gold/Ertiga (The suitable one for MVU work is to be preferred so that it should accommodate minimum three persons with all need based equipment)
- (3) The vehicle must be in road worthy condition, shall not be more than 3 years old from the date of engagement in MVU (Mobile Veterinary Unit) and must have valid registration certificate, Insurance certificate, Fitness certificate, valid contract carriage permit, pollution certificate, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
- (4) The driver of the vehicle must have a valid driving license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- (5) The driver should be well behaved, gentle and obedient in nature.
- (6) A non-refundable amount of Rs.500/- shall be deposited by the intending bidders in shape of account payee bank draft drawn in favour of the Chief District Veterinary Officer, Kendrapara and submitted along with the tender as Bid processing fee.
- (7) The monthly rate of hiring charge including all taxes should be quoted neatly in the General Information for hiring vehicles (excluding fuel) (Annexure-II).
- (8) The vehicle must achieve a fuel efficiency of 10 Kms per litre. (Minimum)
- (9) The details of the make and year of manufacture of the vehicle, registration no., mileage (Kms Covered per litre) and name of the driver with driving license no. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender.
- (10) The Quotation completed in all respect should reach the authorized officer (ADVO (D.C.), Kendrapara) on or before 20/03/2023 by 11AM and shall be opened on the following date.
 - (A) Rajnagar, Rajkanika & Aul: Tender will be opened on.21.03.2020 at 11 AM.
 - (B) Pottamundai, Kendrapara & Derabis: Tender will be opened on.22.03.2020 at 11 AM.
 - (C) Marshaghai, Mahakalpada & Garadpur: Tender will be opened on.23.03.2020 at 11 AM.
- (11) Quotations received after the due date and time will be out rightly rejected.
- (12) Maximum hiring charges of MVU vehicle is Rs.31, 000/ (Including GST).
