





Sealed quotation/tenders are invited from interested reputed Travel agencies/ tour operators of private individuals for providing 1(one) no AC Bolero Diesel/car driver vehicle having sitting capacity not more than Ten including driver. Which shall concerned in terms and conditions (Annexure-II) for official used in Tahasil office Garadpur on monthly rent basis.


- 1) The vehicle must be in Road Worth condition , shall not be more than three years old from the date of initial registration and must have valid registration certificate , insurance certificate, fitness certificate valid contract carriage permit , proff up to date tax payment etc which are mandatory for playing of vehicle.
- 2) The Driver of the vehicle must have a valid Driving Licence for driving for light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 3) The Driver should be well behaved gentle and obedient in nature.
- 4) A sum of rupees 5000/- shall be deposited by the intending bidders in shape of account payee bank draft drawn in favour of The Tahasildar , Garadpur and submitted along with the tender as security deposit. After completion of tender process , the amount will be refunded to unsuccessful bidders.
- 5) The monthly rate of hire charges be quoted separately in the general information (including) fuel and lubricants.
- 6) The vehicle must achieve a fuel efficiency of 12 KMS per litre / 10 KMS per litre.
- 7) The details of the make and year of manufacture of the vehicle registration mileage (KMS) covered per litre and name of the driver with driving licence no. and period of validity should be specifically provided in the general information to be furnished with the quotation /tender (Annexure-III)
- 8) The quotation completed in all respect should reach the undersigned on before dt. 29.03.23 and shall be opened on the same day at 1.00 P.M. presence of bidders of their authorized representatives.
- 9) The application form of quotation/tender containing general bid information and terms and conditions for Hiring of vehicles etc will be available with Tahasildar, Garadpur.
