INVITATIONS FOR BIDS THROUGH e-Procurement

1.The Sub-Collector–cum–Chairman, R.M.C. Kendrapara invites Percentage Rate bids in **single cover system** in online mode for the construction of works as detailed in the table, from the class of eligible contractors as mentioned in column – 6 (six) registered with the State Governments and contractors of equivalent Grade / Class Registered with Central Government / MES/ Railway/CPWD for execution of civil works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under State Government has to register under the appropriate registering authority of the State Government of Odisha in appropriate class of eligibility before award of the work.

2.The bidders may submit bids for the following works.

1. Bid documents consisting of Plans, specifications, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in the website : www.tendersorissa.gov.in.
2. The Tender Paper cost and Earnest Money Deposit / Bid security of the amount specified for the work in Col. 04 and 05 above, the bidder shall make electronic payment using his / her Internet banking enabled account with designated Bank or their aggregator Bank such as SBI / ICICI / HDFC or the bidder having account in other bank can make payment using NEFT / RTGS facilities of designated banks . Bidders desirous to hire machineries or equipment from outside the State or owned but deployed outside the state are required to furnish 2 % of the amount put to tender as Bid security.
3. The Bid documents will be available in the website : www.tendersorissa.gov.in from 10.00 AM of **03.06.2023 to 16.06.2023 up to 5.00 PM** for online bidding.
4. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-I.
5. Bids shall be received only "on line" on or before 24.04.2023 up to 5.00 PM.
6. Bids received on line shall be **opened at 11.00 AM on 17.06.2023** in the office of the Sub-Collector, Kendrapara in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
7. After the date and time of receipt of bid is over, The original affidavit regarding authentication of the documents shall be submitted in the Office of the Regulated Market committee, Kendrapara .
8. The cost of bid documents as mentioned in Column 5, the bidder shall make electronic payment using his / her Internet banking enabled account with designated Bank or their aggregator Banks such as SBI / ICICI / HDFC or the bidder having account in other Bank can make payment using NEFT / RTGS facilities of designated Banks .
9. The Engineer contractor willing to avail the Exemption of EMD will submit scan copy of the affidavit to avail the exemption along with bid document and original affidavit will be

submitted before opening of technical Bid. Affidavit should contain how many times such facilities have been availed by him prior to this during the current financial year. Otherwise they will not be entitled to avail such facilities.

10. Other details can be seen in the bidding documents.
11. The authority will not be held responsible for any technical snag or network failure during on-line bidding.
12. The authority reserves the right to cancel any or all bids without assigning any reason.
