The tender cost fee of Rs.500.00 (Non-refundable) by way of separate demand draft drawn in favour of **Rogi Kalyan Samiti, DHH, Kendrapara**.
2. The Bidder should specifically superscribe "AUCTION SALE NOTICE " on the outer envelope containing the Bid.
3. The tender paper will be rejected if the bidder changes any clauses or Annexure of the bid document downloaded from the web site.
4. The interested bidders may inspect the old instruments, equipment's, furniture, BCL and other items at DHH, Kendrapara, SDH, Pattamundai, all CHCs and PHCs of Kendrapara district during working days from dt.01.12.2023 to dt.11.12.2023 between 11 A.M to 4 P.M. For clarification they may contact the In-charge of the respected institutions.
5. The bid documents should be reached the undersigned on or before 5 P.M of Dt.12.12.2023. through speed post/Regd.Post or courier, which will be opened in the presence of the bidders or their authorized representatives on Dt-13.12.2023 at 11.30 A.M. at DTU Office of the CDM & PHO Kendrapara. The bidders or their authorized representatives should be present at the time of opening of the tender documents.
6. The bidders should enclose bank draft of Rs.10000.00 (Rupees Ten thousand only) in favour of **Rogi Kalyan Samiti, DHH, Kendrapara** towards the cost of EMD. The EMD of the successful bidder will be refund without interest after completion of total lifting of the condemned items.
7. At the time of selection, the major item selected (H1) bidders will be asked to negotiate to upgrade their offers for lifting all the condemned items with H1 price offer by the minor items selected bidders.
8. The condemned articles shall be handed over to the successful bidders only after receipt of its full value within stipulated period as per the tender conditions.
9. The successful highest bidder will deposit the security money of Rs.50, 000.00 (Rupees fifty thousand) only till completion of auction sale process. If successful bidder violate the terms & Conditions at any interval of the sale process, the security deposit and EMD amount will be forfeited.
10. The successful bidder will lift the condemned scrap articles after deposit of full auction value in the store section on proper weighment.
11. The EMD of unsuccessful bidders will be refunded after finalization of the tender.
