

THE PROCEEDING OF THE TENDER COMMITTEE MEETING FOR SELECTION OF SERVICE PROVIDER TO SUPPLY MANPOWER (GROUP-D EMPLOYEES) FOR OFFICE OF THE COLLECTOR & DISTRICT MAGISTRATE , KENDRAPARA HELD ON 20.07.2024 AT 04.30 P.M IN THE CONFERENCE HALL OF THE COLLECTORATE , KENDRAPARA

The Tender Committee meeting was convened on 20.07.2024 at 04.30 P.M under Chairmanship of the Collector & District Magistrate, Kendrapara for supply manpower ("Group-D" employees) for office of the Collector & District Magistrate, Kendrapara held on 20.07.2024 at 04.30 PM in the conference hall of the Collectorate, Kendrapara.

All the committee members were present in the meeting as Annexure-A.

At the outset, the chairman welcomed all members present in the meeting.

The Deputy Collector (Esst.) apprised to the Committee that, the Guidelines and the detail specification regarding supply of manpower ("Group-D" employees) for office of the Collector & District Magistrate, Kendrapara. There are 12 nos of bidders had submitted (As per Annexure-B) their tender papers and all the tender paper were opened before all the committee members and the authorized persons of the bidders.

As per the terms and conditions the technical bids were verified on 19.07.2024 and as per request of the bidders it was unanimously decided to have presentation session on 20.07.2024 at 04.00 P.M at the conference hall of the Collectorate, Kendrapara. Accordingly, all the bidders presented their PPT presentation before the committee members. On technical evaluation including presentation marks obtained by the bidders, it is found that all the 12 nos of bidders have obtained more than qualifying marks, hence it was decided to open the financial bids on the spot. The financial bids of all the 12 nos of the bidders were opened and a comparative statement was prepared and annexed in "Annexure-C".

Basing upon the scores obtained in the technical bid, financial bid and as per the QCBS method, it is found that "M/S- Group-5 Security Services, plot No-33/1689, Cuttack-Puri road, Rasulgarh, Bhubaneswar-751010 has secured the highest marks.

All the Committee members unanimously decided to award the contract to the above said supplier as per the terms and condition of Tender call Notice vide Letter No-930/ dt-02.07.2024.
