

Copy to all Officer-in-Charge of Excise Station and Range Inspector of Excise in this district with instructions to affix conspicuously one copy of the Notice in the locality in which the shop to be opened. This apart, content of the public Notice should also be proclaimed by the beat of drum or such order manner as may be found convenient. In one copy of the Notice signature of the local residents should also be obtained and sent to this office at an early date in proof of wide publicity proof the Notice. All other possible measures should also be taken for wide publicity of the Notice in the specified locality and local area. Two Xerox copies of the served copy of the Notice should also be submitted along with the original served copy for necessary action at this end.

Copy to all concerned Chairpersons, Panchayat Samities/Municipality (Through concerned Officer-in-Charge of Excise Station) for information and necessary action. Copy to concerned Sarapanch(s)(Through concerned Officer-in-Charge of Excise Station) in the District for information and necessary action.

Copy to the Inspector of Excise, Kendrapara (Range) / Pattamundai (Range) for information and necessary action. They must personally ensure that, the public notices are given wide publicity and signatures in token of service / wide publicity of the notice are obtained by the concerned OICs of Excise Station and served copies of the notice in Triplicate (in respect of each shop) are submitted to this Office within 7 (Seven) days without fail.

Copy to the Superintendent of Police, Kendrapara / Sub-Collector, Kendrapara / D.I. & P.R.O., Kendrapara for information and necessary action.

Copy to OIC NIC, Kendrapara for favour of kind information and necessary action. He is requested to place it in the district website for wide publicity.
