

MINUTES OF THE MEETING ON PROVISION OF PENSION AND OTHER BENEFITS TO THE DETAINEES UNDER MISA/DIR/DISIR DURING THE EMERGENCY PERIOD 1975-77 UNDER THE CHAIRMANSHIP OF THE COLLECTOR & DISTRICT MAGISTRATE, KENDRAPARA HELD ON 13.01.2025 AT 07.00 P.M. IN THE CONFERENCE HALL OF COLLECTORATE, KENDRAPARA.

In pursuance of the Letter No.40/C, Dated, Bhubaneswar, the 13th January, 2025 of the Additional Secretary to Government, Home (Special Section) Department, Government of Odisha, a Co-ordination meeting on provision of pension and other benefits to the detainees under MISA(The Maintenance of Internal Security Act, 1971) or DIR (The Defence of India Rules) or DISIR (The Defence and Internal Security of India Rules) during the emergency period from 25.06.1975 to 21.03.1977 under the chairmanship of the Collector & District Magistrate, Kendrapara in respect of Kendrapara District held on dated 13.01.2025 at 07.00 p.m. in the Conference Hall of the Collectorate, Kendrapara in presence of the Addl. District Magistrate (Rev.), Kendrapara, Additional Superintendent of Police, Kendrapara, Deputy Superintendent of Police, DIB, Kendrapara, DI&PRO, Kendrapara & Superintendent, District Jail, Kendrapara.

Detail discussion was made as per resolution of the State Government vide the Letter No.26/C, Bhubaneswar, Dated the 13th January, 2025 of the Hon'ble Additional Chief Secretary to Government, Home (Special Section) Department and after careful consideration, have been pleased to provide pension and other benefits, as indicated below, to the persons detained in the Jail in State of Odisha under MISA or DIR or DISIR during the period from 25.06.1975 to 21.03.1977.

- (i) Pension of Rs.20,000/- (Rupees twenty thousand) only per month shall be sanctioned in favour of the living persons(i.e. those who were alive as on 01.01.2025) irrespective of the period of detention in Jail; and
- (ii) Free Medical Treatment can be availed as per the provisions contained in Health & Family Welfare Department Resolution No.24786/H, dated 21.10.20096 and Letter No. 9990/H, dated 24.04.2010.

A detailed guidelines in this respect is annexed herewith as Annexure-I.

These benefits will be provided for the period starting from 1st January, 2025.

No benefits shall be paid for the period to 1st January, 2025.



This has been concurred in by Finance Department vide their OSWAS File No. FIN-GS1-PEN-0040-2024.

The above pension will be given in favour of detainees, who were alive as on 01.01.2025 under MISA/DIR/DISIR during the period from 25.06.1975 to 21.03.1977 in the District of Kendrapara.

The Applicant has to submit an application in the prescribed format (enclosed herewith) to the Collector & District Magistrate, Kendrapara with relevant documents and name of three Prominent Co-Prisoners along with an Affidavit(affidavit should be executed by an Executive Magistrate) in support of his /her detention under MISA or DIR or DISIR during the said period in the State of Odisha.

The Application Form shall contain the Name, Father's /Husband's Name, Date of Birth, Address(both permanent and correspondence), Aadhaar Number(with copy of Aadhaar Card), Bank Account details, Period of detention & Place of detention, Space for Passport size photograph, Identification mark of the Applicant, Name of the treasury from where intends to receive the pension and undertaking in the prescribed format.

On receipt of application, the same shall be placed before the Dist. Level Committee.

A District Level Committee is formed headed by the Collector & District Magistrate, Kendrapara, with Superintendent of Police, Kendrapara and Superintendent of District Jail, Kendrapara as members for receipt of scrutiny of the applications.

The District Level Committee shall prepare the list of eligible beneficiaries.

The Collector & D.M., Kendrapara shall furnish the said list of eligible applicants recommended by the Dist. Level Committee along with supporting documents to the Government in Home Department for consideration.

After threadbare discussion on the above matter, it was decided that,

The Collector & D.M., Cuttack (un-divided District i.e. Cuttack) is requested to furnish detailed list of detainees, who were detained in the Cuttack Jail under MISA/DIR/DISIR during the period from 25.06.1975 to 21.03.1977 at an early date for sanction of Pension under the above Act and Rules.

The Senior Superintendent, Cuttack Circle Jail, Cuttack at Choudwar is requested to furnish the detailed list of the detainees, who were detained in your Circle Jail under the



MISA/DIR/DISIR during the period from 25.06.1975 to 21.03.1977 at an early date for sanction of Pension under the above Act and Rules.

The Superintendent of District Jail, Kendrapara is directed to furnish detailed list of detainees, who were detained in your Circle Jail under MISA/DIR/DISIR during the period from 25.06.1975 to 21.03.1977 immediately for sanction of Pension under the above Act and Rules.

The DeGM, Kendrapara is directed to upload the Guidelines and Application Form under MISA/DIR/DISIR Act & Rules in the District Website for wide publicity and information of General Public.

The Deputy Collector,(General & Misc.),Collectorate, Kendrapara is appointed as the District Nodal Officer to monitor & Co-ordinate in the above matter and report to the Collector & D.M., Kendrapara in every fortnight.

The meeting ended with vote of thanks to the Chair.



GUIDELINES FOR CONSIDERATION OF APPLICATION FOR SANCTION OF PENSION AND OTHER BENEFITS TO THE DETAINEES UNDER MISA OR DIR OR DISIR.

1. This pension will be given in favour of detainees (who were alive as on 01.01.2025) under MISA or DIR or DISIR during the period from 25/06/1975 to 21/03/1977 in the State of Odisha.
2. The applicant has to submit an application in the prescribed format (enclosed herewith) to the Collector & District Magistrate of concerned district along with relevant documents and name of three Prominent Co-prisoners along with an Affidavit in support of his/her detention under MISA or DIR or DISIR during the said period in the State of Odisha.
3. The application form shall contain the Name, Father's/Husband's Name, Date of Birth, Address (both permanent and correspondence), Aadhaar Number (with copy of Aadhaar card), Bank Account details, Period of detention & Place of detention, Space for Passport size photograph, Identification mark of the applicant, Name of the treasury from where intends to receive the pension and undertaking in the prescribed format.
4. On receipt of application, the same shall be placed before the District level committee headed by the Collector & District Magistrate, with Superintendent of Police of the district and Jail Superintendent(s) of the District/Special Jails/Sub-Jails as members for scrutiny of the applications. The said Committee shall prepare the list of eligible beneficiaries.
5. The concerned Collector & D.M. shall furnish the said list of eligible applicants recommended by the Committee along with supporting documents to the Govt. in Home Department for consideration.
6. A State Level Committee comprising of Secretary (Home Department), Secretary (Finance Department), Secretary(Law Department), Financial Advisor (Home), Director General (Police) and Director General (Prisons) will be constituted to consider the recommendations received from the respective District Collectors.
7. Home Department will obtain Govt. Order for extension of benefit in favour of eligible applicants basing on the recommendation of the above State Level Committee and issue sanction order in favour of the eligible applicants for drawal of pension. The said order shall be addressed to A.G. (A & E), Odisha, Bhubaneswar with a copy to the Collector, District- /DTI (O)/ DG of Police/ SP, District- / concerned District Treasury/ person concerned etc.
8. On receipt of the said order, the O/o the A.G (A & E), Odisha, Bhubaneswar will issue authority to concerned Treasury under intimation to all concerned (Home Department and person concerned). The said Treasury will take steps for drawal of pension in favour of the applicant after due diligence at their level.

9. Health & FW Department shall issue necessary Resolution in favour of the beneficiaries getting pension following the resolutions mentioned at point No. (ii) of the resolution.
10. At any time, if it is found that the benefits have been availed by submitting false information, the same shall be withdrawn immediately and necessary prosecution may take place including recovery with penal interest of 12% per annum.
11. The benefits allowed in favour of any person can be withdrawn/ ceased, if the said person is found to be involved in any anti-national activities/ criminal activity or punished by the Court of law for any criminal offence.
12. The monthly financial benefit shall be disbursed to eligible applicant in each month by the concerned treasury adhering to the instruction issued by the Finance Department/Home Department as the case may be.
