Expression of Interest (EOI) is invited by Chief District Agriculture Officer, Kendrapara from the experienced and interested farmer producer organization (FPO), Cooperative or public/private Corporation operating the Oilseed sector for management of cluster under NMEO-OS 2025-26 interested farmer producer organization (FPO), Cooperative or public/private Corporation operating in the Oilseed sector are requested to submit their Expression of interest (EOI) in sealed envelope super scribed as application for engagement as value chain partners (VCPs) for implementation of NMEO-OS in cluster approach for the year 2025-26 for Kendrapara District by registered/speed post. The proposals in Email would not be entertained in this regard. The Expression of interest (EOI) should be addressed to the office of the Chief District Agriculture Officer, Kendrapara. The last date for receipt of the (EOI) is 01.05.25 up to 11.00AM and the same shall be opened on the same day in presence of authorized signatory and representatives. The authority shall not be responsible for any sort of postal delay and the EOI received beyond scheduled date and time and shall have out right be rejected.

Eligibility criteria for FPOs/Cooperatives

1. Should be registered under the companies Act or Cooperative Act.
2. Should have an experience of at least 3 years working in the district where the cluster is formed.
3. At least 200 farmers (100 for Northeast and Hilly regions) should be registered in the FPO or Cooperative.
4. Average annual turnover in the past 3 years should be greater than Rs.9 lakhs
5. Equity of at least Rs. 3 lakhs by the farmers in the FPO. Recipients of any Equity Grant by the Government shall be given preference.
6. FPOs formed under the 10000 FPOs scheme, FPOs associated with Oilseeds registered with public agencies such as NAFED, NSC-OS etc.




