
OFFICE ORDER

Keeping in View of the Prevailing Heat wave like Situation in the District & in order to safeguard the health & Wellbeing of the Students of all Recognized, Government Aided and Government Elementary, Secondary Schools, Higher Secondary Schools, Special Schools of State Govt./Central Govt. & autonomous Societies thereof including the schools of ST & SC Development, Minorities & Backward Classes Welfare Department / Social Security & Empowerment of Persons with Disabilities Department (SSEPD) & Anganwadi Centres of Women & Child Development & Mission Shakti (WCD&MS) Department functioning in the District of Kendrapada, the following order is being Passed for scrupulous adherence by the respective School authorities.


1. All Schools as aforesaid Shall function between 6.30 AM to 09.00AM in the morning.
 2. The School authorities shall be required to modulate their internal Examination Schedules & that of other Examination related activities, if any, conveniently as far as Practicable.
 3. The School authorities shall take all precautionary measures befittingly, scrupulously, adhering to the guideline issued by the SRC, Odisha & District administration from time to time.
 5. The census and SIR work as assigned shall be continued taking all precautions.
- However, this order shall remain in force with immediate effect from 21.04.2026 until further instruction.
